Individuals must be citizens of the Republic of Cyprus, or third country nationals who reside legally in the Republic and are entitled to free access to the labor market

The personal assistance allowance is intended to help cover the costs of hiring a personal assistant

The personal assistant is a person who, under the direction of the person with a disability, carries out certain basic tasks in their daily life and/or accompanies them to facilitate their access to employment, training, leisure, and social participation

The purpose of this benefit is to promote a more autonomous life in the usual environment which facilitates care in a personalised and integrated way according to the circumstances and needs of the person in a situation of dependency, helping them to fully integrate into society

## Deduction for job creation for workers with disabilities

(Date of funding announcement 27 November 2014) The following amount will be deductible from the gross tax liability:

9,000 euros for each person/year of increase in the average workforce of workers with a degree of disability equal to or greater than 33% and less than 65%, hired by the taxpayer, experienced during the tax period, with respect to the average workforce of workers of the same nature in the immediately preceding period

12,000 euros for each person/year of increase in the average workforce of workers with a degree of disability equal to or greater than 65%, hired by the taxpayer, experienced during the tax period, with respect to the average workforce of workers of the same nature in the immediately preceding period

The workers hired that would give entitlement to this deduction will not be computed for the purposes of the freedom of amortisation with job creation regulated in article 102 of the Ley del Impuesto sobre Sociedades (Corporate Tax Law)

With effect for tax periods beginning on or after 7 November 2018, organisations that hire a worker to carry out their activity in the Canary Islands will be entitled to enjoy the tax benefits for job creation established by the tax regulations in accordance with the aforementioned requirements, increasing them by 30 per cent

It will be adjusted taking into account the type and degree of disability of the ultimate beneficiaries of this programme, as well as the stability of the jobs they hold at the start date of the incentive period or the start date of the employment relationship if this is later, in the terms indicated in article 12 of the Order of 21 June 2024, which approves the regulatory bases

The first regulation on public employment services in Turkey was made with the Labor Law No. 3008 of 1936, which defined the job-finding intermediary service as a public service under state monopoly. In this context, The Employment Agency (İŞKUR) was established in 1946 with Law No. 4837, and its mission was defined as intermediating in finding suitable jobs for workers and suitable workers for employers.

Employment of Persons with Disabilities

Registration of persons with disabilities with İŞKUR

Citizens who certify that they are deprived of at least 40% of their whole body function loss according to their disability status with a disability health board report from authorized health institutions can register as "disabled".

Ratios such as the rate of loss of ability to work in the profession are not taken into account and the rate of loss of whole body function is taken into consideration.

If the disability health report states that the person cannot work, the person is not registered as disabled.

#### Related Legislation

In Turkey, the employment of disabled people as workers is tried to be ensured through the quota system stipulated in Article 30 of the Labor Law No. 4857.

Within the scope of the quota system stipulated in Article 30 of the Labor Law No. 4857;

- employ 50 or more workers (51 or more in agricultural and forestry enterprises);
- 3% disabled in private sector workplaces,
- In public workplaces, they are obliged to employ 4% disabled and 2% ex-convicts or workers who have been injured in the fight against terrorism in a way not to be considered disabled in jobs suitable for their occupational, physical and mental conditions.

Monitoring and Audit

Pursuant to Article 30 of the Labor Law No. 4857, quotas for disabled people who are obliged to be employed are regularly monitored on a monthly basis by the Provincial Directorates of Labor and Employment Agency. Disabled labor force requests received by contacting employers with a shortage of disabled quotas are published on the website of the Institution and efforts are made to close the remaining open quotas
